## **CLARIFICATION**

COVID-19-The Epidemic Diseases Act, 1897- Clarification to Revised Lockdown-Orders

## Reference:

 Government Notification, Revenue and Forest, Disaster Management, Relief and Rehabilitation Department Dated-25th March 2020

With reference to the revised lockdown order issued by GoM dated 25/03/2020, (hereinafter referred to as "said order") following explanations/ clarifications are issued regarding para 8 (industrial establishments):

- 1. All industrial activities falling under 8(a) and 8(b) do not require any permission to operate. No written/electronic prior permission is needed to restart or to continue the production activities. The district authorities must ensure single-point movement permissions (if required) for labour/workforce requested by the unit. As GoI has allowed goods transport, all movement of goods (warehouse-stockist-wholesales-retailer) need no permission. The self-declaration on the vehicle (stickers) should be treated as adequate. The units must operate on barest minimum staff and must follow the guidelines issued regarding internal hygiene, social distancing, health monitoring etc.
- All necessary packaging units required for industrial units of 8(a) in the said order are allowed to operate.
- 3. To ensure the uninterrupted supply chain of raw material for all industrial units in the said order, all units which produce such raw material are allowed to operate. The raw material supplier must ensure that it is on the 'list of suppliers' to the concerned manufacturers before the date of said order. Any

breach will lead to suspension of licences to such raw material producing units.
