In compliance with the guidelines of the Ministry of Home Affairs, Government of India vide Order No. 40-3/2020-DM-I(A) dated 15th April, 2020 the following activities are permitted for Shillong Urban Agglomeration and Mylliem Block of East Khasi Hills District, with effect from 24th April, 2020.

The Deputy Commissioner, East Khasi Hills will continue to regulate the schedule and timing of the outlets and the relevant activity. The Deputy Commissioner, East Khasi Hills should ensure that all SOPs for social distancing as per para 3(i) and Annexures I & II of the above MHA order are in place and are followed.

The Deputy Commissioner, East Khasi Hills may add items to this list only after approval of the Political Department.

The Deputy Commissioner, East Khasi Hills to also take note of Para 4 of the Revised Consolidated Guidelines of MHA dated 15th April, 2020 which is quoted below:

- "(i) State/UT Governments shall not dilute these gudielines issued under the Disaster Management Act, 2005 in any manner, and shall strictly enforce the same
- (ii) State/UT Governments, may, however, impose stricter measures that these guidelines as per requirement of the local areas."
- 1. Commercial and private establishments, as listed below, will be allowed to operate:
 - i. Shops dealing in Essential Goods as notified by Political Department, Government of Meghalaya vide Order No. POL.75/2020/PtI/13 dated 21st April, 2020.
 - ii. Courier services for essential goods as notified by Political Department, Government of Meghalaya vide Order No. POL.75/2020/PtI/13 dated 21st April, 2020.
 - iii. E-Commerce operations in Essential Goods as notified by Political Department, Government of Meghalaya vide Order No. POL.75/2020/PtI/18 dated 22^{nd} April, 2020.
 - iv. Common Service Centres as notified by Political Department, Government of Meghalaya vide Order No. POL.72/2020/82 dated 22nd April, 2020.
 - v. Services provided by self-employed persons, e.g. electrician, IT repairs, plumbers, motor mechanics, and carpenters.
 - vi. Shops for repair of trucks on highways.
- 2. Hardware wholesale shops of Shillong only for the purpose of direct delivery to the site or hardware shops in rural areas after permission from the Deputy Commissioner, East Khasi Hills.
- 3. All agriculture and allied sectors activities like farming operations including livestock farming, Poultry, Fishery and Hatcheries, collection, processing and distribution of milk and milk products, mandis by APMC, procurement and marketing of agricultural produce, Custom Hiring Centers, cold storage and warehouses. Manufacturing, packaging and distribution of agriculture inputs, seed, animal feed and fodder, movement of harvesting and sowing related machines/implements.
- 4. Operation of Tea industry including plantations with maximum 50% of workforce for production, processing, packaging and marketing.

- 5. Transportation of all agricultural products subject to transit point and route specified by respective Deputy Commissioners considering prevailing COVID-19 situation.
- 6. Veterinary Hospitals, Dispensaries, Clinics, sale and supply of medicine and vaccines.
- 7. MNREGA works are allowed with strict implementation of social distancing and face mask. Priority to given to irrigation and water conservation works.
