**ORDER**

Sub: DCK - DM – COVID-19 – Ensuring safety and precautionary measures in Industries – Orders – Issued.

WHEREAS, the recent Gas leakage in one of the Industry at Visakapatnam prompted the District Authority to review the safety and precautionary measures in all the industries and other establishments such as shopping malls, marriage / community halls etc.. It is needless to reiterate that all Industries have to follow the licencing conditions in order to avoid any act of commission or omission that would be detrimental to Environment and to the Community, at large, where such Industries and Establishments are sited.

AND WHEREAS, in view of COVID-19 Pandemic, most of the Industries and establishments have been shut down and attention to proper maintenance might been lacking for one reason or other. Non-compliance of the safety measures in any of the aspects may lead to Industrial disaster.

NOW THEREFORE, in cognizance of the above, in exercise of powers vested under section 30 (2) (v) of the Disaster Management Act, 2005, it is hereby directed that the Labour Department, Department of Industries, O/o the Inspector of Factories, Department of Science, Technology and Environment, Puducherry Pollution Control Committee, Commissioners of all Local Bodies and Fire Service shall ensure that the Industries, Shopping Malls, Marriage Halls / Community Halls etc are following all the safety and precautionary measures as per the Act and Rules and Licencing conditions of the concerned are well in place and periodical inspection have to be conducted by the said departments to avoid any un-toward incidents. The Departments concerned shall issue necessary instructions to all Industries / Commercial units in this regard. A compliance report shall be furnished before 15<sup>th</sup> May 2020.
