**ORDER**

Whereas latest guidelines have been received from the Govt. of India, Ministry of Home Affairs, New Delhi vide no. 40-3/2020-DM-1(A) dated 30-05-2020 and Govt. of Punjab, Department of Home Affairs and Justice, Chandigarh vide no. SS/ACSH/2020/456 Dated 31-05-2020.

Now, I Vinay Bublani, IAS, District Magistrate, Shahid Bhagat Singh Nagar in exercise of the powers conferred upon me under section 144 Cr.P.C. Act, 1973 order that:-

**(1) Movement of persons - Night curfew (9 pm to 5 am):**

The movement of individuals for all the non-essential activities shall remain prohibited between 09:00 PM to 05:00 AM.

**(2) Protection of vulnerable persons:**

The persons above 65 years of age, persons with co-mobility, pregnant women and children below the age of 10 years are advised to stay at home except for essential requirements and for health purposes.

**(3) Prohibited activities:**

The following activities shall continue to be prohibited:

- (i) Cinema halls, gymnasiums, swimming pools, entertainment parks, theatres, bars, auditoriums, assembly halls and similar places.
- (ii) Social/ political/ sports/ entertainment/ academic/ cultural/ religious functions and other large congregations.
- (iii) Spitting in public places.
- (iv) Consumption of liquor, pan, gutka, tobacco etc. in public places is prohibited. However, there will be no restriction on their sale.

**(4). Restricted activities:**

- (i) **Marriage related gatherings** - Number of guests not be exceed 50.
- (ii) **Funeral/last rites** - Number of persons not to exceed 20.

**(5) Religious places/places of worship for public, Hotels and other hospitality services and Shopping malls - will remain closed till 07-06-2020 and for the purpose of opening of the same separate orders will be issued on or before 07-06-2020.**

(6) **Restaurants** - may be opened for take-home or home delivery services but in-dine services to remain closed till 07-06-2020.

(7) **Inter-state movement of persons by domestic flights/trains/buses/cars etc.**

Inter-state movement of persons by domestic flights/trains/buses/cars etc is allowed subject to the condition that the inward passengers would follow the SOP of the Health Department. The passengers would be required to either download Cova-app and get self-generated 'e-pass' or declare their particulars at the airport/railway station/bus stand/inter-state border as the case may be.

(8) **Movement of Buses and Vehicles:**

- i. **Inter - State movement of buses** : is allowed subject to compliance of the SOP which shall be issued by the Transport Department, Punjab.
- ii. **Inter - State movement of passenger vehicles** : Inter-state movement of passenger vehicles like taxis, cabs, stage carriers, tempo-travelers and cars is permitted against self-generated e-pass.
- iii. **Inter - State movement of passenger vehicles** : Inter-state movement of passenger vehicles like taxis, cabs, stage carriers, tempo-travelers and cars allowed without any restriction
- iv. **Bicycles, rickshaws and auto-rickshaws** : is allowed subject to compliance of the SOP as issued by the Transport Department Punjab.
- v. **2-wheelers** : is allowed subject to compliance of the SOP as issued by the Transport Department, Punjab for 1+1 passengers.
- vi. **4-wheelers** : is allowed for 1+2 passengers subject to compliance of the SOP as issued by the Transport Department, Punjab. No pass would be required for permitted activities like shopping, going to office and work place.
- vii. **Inter-State movement of goods** : There would be no restriction on Inter-State movement of goods.
- viii. **Social visits** : By and large, there is no restriction on movement by persons within city or Districts. However, such a movement shall be essential tasks and social visits, with no essential task shall be avoided and restricted. State Department of Health will issue a separate SOP in this regard.

(9) **Opening of Shops:**

Vide order no. 3516-44/MA/COVID-19 dated 08-05-2020 and order no. 4491-4520/MA/COVID-19 dated 23-05-2020 the rotation and timing of each category of shop has been fixed. In order to avoid crowding and congestion the same order with regard to rotation shall continue to be in force. **The shops are allowed to open from 07:00 AM to 07:00 PM. Liquor vends shall however remain open from 08:00 AM to 08:00 PM.**

**Barbar shops, hair-cut saloons, beauty parlours and Spas:** is allowed from 07:00 am to 06:00 pm subject to compliance of the SOP as issued by the Health Department, Punjab.

- (10) **Sports complexes and stadia** : is allowed without spectators as per the SOP of the Health Department.
- (11) **Industries and industrial establishments** : All categories of industries are allowed to operate in both rural and urban areas.
- (12) **Construction activities** : are allowed without any restriction in both the Urban and rural areas.
- (13) **Agricultural, horticultural, animal husbandry, veterinary services** : are allowed without any restriction.
- (14) **E - Commerce** : are permitted for all goods.

(15) **Offices** :

(i) Central Government and Private Offices: allowed to open as per required strength without any restrictions except that compliance of social distancing and wearing of masks at all times, shall be ensured. If so, required, the timings may be adjusted to work in small teams to ensure strict compliance of these restrictions.

(ii) Punjab Government Offices: All the Punjab Government offices would remain open as per required strength. However, Head of the Office will ensure that there is adequate space for maintaining social-distancing norms.

(16) **Social distancing and wearing of masks** :

Social distancing i.e. minimum 6 feet distance (do gaz ki duri) for all the activities shall always be maintained. Keeping in view this aspect, this office vide order 23-05-2020, the rotation and timings of each category shops has been fixed. Further, it has been ensured that principles of social distancing are not compromised.

Wearing of masks by all persons in public places, including work places etc. will be mandatory and must be strictly observed and enforced. In case of non compliance of this penalties will imposed as per Health Department, Punjab Notification No.IDSP/NHM/Pb/20/5849-5857 dated 29-05-2020 (photocopy enclosed).

(17) **Permits and passes** :

(i) No separate permission would be required by the industries and other establishments to resume their operations. All employees, be it government offices, private offices and other work places, would be allowed to move without any requirement of pass during the permitted hours i.e. 05:00 AM to 09:00 PM.

(ii) There shall be no restriction on inter-state movement of persons and no separate permission or E-permit would be required for such movement. However, use of cova-app and self-generated 'e-pass' would be mandatory.

**(18) Use of Arogya Setu :**

Employees are advised to ensure that Arogya Setu is installed by all the employees having compatible mobile phones. Similarly, individuals are also to be advised by the district authorities to install Arogya Setu application on their compliance mobile phones and also regularly update their health status on the app.

**(19) Penal provisions :**


Any violation of this order and Lockdown measures shall be punishable under section 51 to 60 of the Disaster Management Act, 2005 besides legal action under section 188 of Indian Penal Code (IPC).

**(20) Advisories :**

The Health & Family Welfare Department, Punjab has issued advisories on different subjects. All concerned are shall ensure compliance of these advisories as noted below-

- (i) Advisory dated 20.04.2020 for offices.
- (ii) Advisory dated 23.04.2020 for banks.
- (iii) Advisory dated 24.04.2020 for usage air-conditioners in residential/commercial establishments.
- (iv) Advisory dated 25.04.2020 for industry.
- (v) Advisory dated 26.04.2020 for MGNREGA workers.
- (vi) Advisory dated 28.04.2020 for shops.
- (vii) Advisory dated 29.04.2020 for petrol pumps.
- (viii) Advisory dated 30.04.2020 for goods vehicles.
- (ix) Advisory dated 02.05.2020 for senior citizens.
- (x) Advisory dated 06.05.2020 for transport buses.
- (xi) Advisory dated 07.05.2020 for safety of food and other house hold items.
- (xii) Advisory dated 11.05.2020 for inter-state movement of persons.
- (xiii) Advisory dated 12.05.2020 for hotel offering quarantine facility for overseas indians.

This order shall take immediate effect and applicable till further orders.

1. Whereas Government of Punjab has imposed penalties in case of violation of Government instructions and guidelines regarding prevention & control of COVID-19 vide letter No. DSPP/NHM/PB/20/4985 dated 15.5.2020.

2. Whereas for better management and control of COVID-19, it is felt that these penalties need to be enhanced and made more stringent, I, Dr. Avneet Kaur, Director Health Services Punjab, impose the following penalties under regulations framed under Epidemic Disease Act 1897:-

- i) For not wearing a mask in public places: Rs.500/-
- ii) For violating the home quarantine instructions: Rs.2,000/-
- iii) For spitting at public place : Rs.500/-
- iv) For violating social distancing norms by owners of Shops/Commercial places : Rs.2,000/-
- v) For violating the social distancing norms by vehicle owners will be fined as follows:
  - a) Buses: Rs.3,000/-
  - b) Cars: Rs.2,000/-
  - c) Auto-rickshaws/Two-wheelers: Rs.500/-

3. All officials not below the post of B.D.P.O, Naib Tehsildar, A.S.I. and any other official authorized by Deputy Commissioner can impose the aforementioned penalties under the provisions of Epidemic Disease Act, 1897.

4. Non-payment of fine by the violator will attract proceeding under section 188 of IPC as per the regulations framed under the Epidemic Disease Act, 1897.
