
ORDER

In pursuance of Ministry of Home Affairs order No. 40-3/2020-DM-I(A) Dtd. 1st May, 2020 and in compliance to the order No. CS/COVID-19/01/2020/32 Dtd. 04/05/2020 received from Govt. of Arunachal Pradesh, the following guidelines will be applicable in East Siang District w.e.f 04/05/2020 till further order :-

ACTIVITIES PERMITTED :-

1. All shops in urban areas, markets, market complexes (essential and non essential), Urban single non-essential shops, all Standalone (Single) shops and neighborhood (colony) shops. All commercial establishments/Shops should ensure strict compliance of social distancing norms, hand hygiene and other Govt. guidelines. **Timing for operation of market/Shops/Commercial establishment is fixed from 07:00 AM to 04:00 PM**
2. Medical clinics, Non-Covid medical services, OPD.
3. E-Commerce (Labour should not be brought from outside state)
4. Urban areas : Industrial establishments (SEZ, EOU industrial estates and townships) , manufacturing of essential goods, drugs, Pharma, medical devices, their raw materials and intermediaries.
5. Bamboo Industry (with staggered shifts and social distancing), manufacturing units of packaging materials.
6. Urban in situ construction (Labour should not be brought from outside state).
7. Private offices to operate with minimum workforce (Labour should not be brought from outside state).
8. Govt. Offices: visitors should be avoided. **All concerned HoDs/HoOs, of the district to devise ways to provide services with minimize visit to office by public.**
9. All Agricultural related activities. (Labour should not be brought from outside state). Tea Garden should continue to abide by the guidelines.
10. Bank & financial institutions, Courier & postal, Goods traffic.
11. Rural areas: All industries and construction activities (Labour should not be brought from outside state).
12. Shops in rural areas (except in malls).
13. Intra-district and inter-district movement of persons.
14. The Inter-state movement of persons through Assam will be permitted to move in non-stop convoys twice a day. **The Superintendent of Police, East Siang District and DTO(MV), East Siang District to comply in consonance with public notice issued by Commissioner (Home) Annexed Vide No. HMB(A)-70/2020 Dtd. 04/05/2020 at Annexure-I.**
15. Buses, Rickshaws, cycle rickshaws, Taxi, Inter-District Bus, Intra-District Bus and other public transport to run at 50 % occupancy only. **For any violation, the concerned transport service operator/ owner will be held responsible and will be liable to a fine of Rs. 1,000/-.** Further, Public transportation to be sanitized using disinfectant regularly.

16. Free movement of goods carriers for all intra-district and inter district movement is permitted only between 05:00 A.M to 07:00 P.M. However, for inter-state movement of goods carriers, in compliance of order No. Pol-67/65/Vol-V/237 Dtd. 17/03/2020 from Commissioner (Political), Govt. A.P, Itanagar and Order No. CS/COVID-19/01/2020/32 Dtd. 04/05/2020 at Annexure-2 point No. IV and in consonance with Bengal Eastern Frontier Regulation Act-1873 "Plying permit will have to be obtained from DC Office, Pasighat/ADC, Meho/ADC Ruksin. E-Pass for this purpose may be obtained from DC office in the given link – <https://eservice.arunachal.gov.in/>

Further, such inter-state goods vehicles entering East Slang District should exit from the District within the same day of arrival. Any violator will be prosecuted under relevant section of law.

17. All kinds of Construction/ Industrial activity with strict implementation of norms for new normal. (Labour should not be brought from outside State).
18. Asymptomatic persons/individuals returning to Arunachal Pradesh shall be placed in Institutional Quarantine facility, followed by mandatory sample collection for PT-PCR test after 3/14 days. Revised SOP is annexed herewith as **Annexure-03**

ACTIVITIES PROHIBITED:-

1. Weekly market is strictly prohibited.
2. All domestic and international Air travel of passengers, except for medical services, air ambulance and for security purposes or for purposes as permitted by MHA.
3. All passenger movement by trains, except for security purposes or for purposes as permitted by MHA.
4. Inter-State Buses for public transport, except as permitted by MHA
5. Inter-State movement of individuals except for medical reasons or for activities as permitted by MHA. In case of such exigencies, e-passes may be applied on this link :- <https://eservice.arunachal.gov.in/>
6. All schools, colleges, educational, training, Coaching institutions etc. However, online/distance learning is permitted.
7. Hospitality services other than those used for housing health/police/ Govt. officials/health care workers, stranded persons including tourists and those used for quarantine facilities. Bakery/ food joint may provide takeaways but gathering in the shops is strictly prohibited.
8. All cinema halls, shopping malls, Gymnasiums, Sports complexes, swimming pools, entertainment parks, Beauty parlour, theatres, bars and auditoriums, assembly halls and similar places.
9. All social/political/sports/entertainment/academic/cultural/ religious functions/ other gatherings. River site picnics is prohibited.
10. All religious places/places of worship shall be closed for public. Religious congregations are strictly prohibited.
11. Persons above 65 years of age, persons with co-morbidities, pregnant women and children below the age of 10 years should stay at home except for meeting, essential requirements and for health purposes as per the National Directives.

All other guidelines for workplaces and public places as annexed herewith at Annexure-II should be strictly adhere to.
