NOTIFICATION

In exercise of the powers conferred under section 112 of the Factories Act, 1948 (Act No.63 of 1948) it is proposed to makes the following amendment to the Andhra Pradesh Factories Rules, 1950 as subsequently amended, is hereby published for general information as required in terms of Sub-section (1) of Section 115 of the said Act.

Notice is hereby given that the said draft amendment will be taken into consideration by the Government on or after expiry of forty five (45) days from the date of publication of the Notification in the Andhra Pradesh Gazette and that any objections or suggestions which may be received by the Government from any person with respect there to within the aforesaid period will be taken into consideration by the Government of Andhra Pradesh.

The words "Woman or" Shall be omitted.

(6) in Schedule XIX at Para 2(ii)

The words "Woman or" Shall be omitted.

(7) in Schedule XXII at Para 15,

The words "Women and" and "Woman or" Shall be omitted.

(8) in Schedule XXXI at Para 9,

The words "Women and" and "Woman workers and" shall be omitted.

(9) in Schedule XXXII at Para 4,

The words "Women and" and the Clause (b) shall be omitted.
