This has reference to meeting of the ESIC Standing Committee where the members shown their concern for the no-of non complying employers in employer data base. As per the data received from the back end, the position of total, contributing, never-contributed and partially contributing employers is as under:

All Regional Director are advised to take action on these 531607 and 470141 employers who have never contributed or partially contributed as per the following procedure:-


1. The Cases migrated prior to 2011 and non-compliance is observed since the migration and no dues are pending may be closed after verifying the status of the units.
2. Some employers might have generated multiple code numbers and they are making compliance on a single number, status of other code number on which employer is not making compliance may be updated as closed in the system after confirming the status from the employer.
3. The units which have closed 5 and more years earlier and there are no outstanding dues against the employer, status of these units may be updated as temporary closed in the system after verifying the status of the unit.
4. The status / compliance status of the partially contributing may be reviewed and if any unit is found closed 5 or more years ago, status of unit may be updated as temporary closed in the system and revenue action on remaining units may be taken as per extant provisions.

The field offices simultaneously check the status of units from GST Department, EPFO, The Labour Department etc. The list of region-wise (office-wise) breakup of these employers is enclosed with this letter. The whole exercise is

to be completed within a time span of 2 months and a Action Taken Report be sent to this office for placing before the Standing committee.
