ORDER:

The Election Commission of India has notified 27.02.2023 (Monday) as the poll day for the Bye-Election to Tamil Nadu Legislative Assembly from 98. Erode (East) Assembly Constituency, in Tamil Nadu. 27.02.2023 (Monday) has to be declared as public holiday under section 25 of the Negotiable Instruments Act, 1881 (Central Act XXVI of 1881).

2. The following Notification shall be published in an extra-ordinary issue of the Tamil Nadu Government Gazette dated 09.02.2023.

Notification

Under the "Explanation" to Section 25 of the Negotiable Instruments Act, 1881 (Central Act, XXVI of 1881) read with the Notification of the Government of India, Ministry of Home Affairs No. 20-25-26, Public -1, dated the 8th June 1957, the Governor of Tamil Nadu hereby declares Monday, the 27th February 2023, the date on which the poll for the Bye-Election to Tamil Nadu Legislative Assembly from 98. Erode (East) Assembly Constituency will take place in the areas comprised in the above said Assembly Constituency lying in Erode to be a Public Holiday.

2. Further, all employees working in Erode and neighbouring districts but registered as voters in 98. Erode (East) Assembly Constituency, shall also be given a paid holiday on 27.02.2023.

3. All the Government offices including industrial establishments of the Government controlled bodies and all the educational institutions throughout the area comprised in 98. Erode (East) Assembly Constituency lying in Erode district will remain closed on 27.02.2023.
