- Food, Food Products & other allied industries including transportation.
- Milk, Milk Products & allied industries including transportation.
- Agriculture, Vegetables, Fruits and Industries related to these packaging & procurement including transportation
- 4. Face Mask.
- Hand Sanitizer.
- Disinfectants, Alcohol and Bleach based.
- Packaging Industries working for food and pharma industries.
- 8. All Pharmaceuticals and Medical Industries.
- 9. Poultry/Meat/Fishery Processing Unit.
- 10. Food Irradiation Unit etc.
- 11. Cattle/Poutry feed/ Animal Feed manufacturing and transport.
- 12. Industrial Units manufacturing water purifiers and purified water.
- 13. Industries manufacturing equipments/ materials used in public health services.
- 14. Electricity generation, distribution and transmission.
- IT services, IT Enabled services and Data Centers providing services to any essential industries.

- 18. Continuous process industries, which cannot be stopped, the decision whether it is essential or not, will lie with the District Magistrate.
- 19. If there is a doubt about as to whether an establishment is essential or not, the District Magistrate, shall give a final decision on the same.
