**ORDER**  
(u/s 144 Cr.P.C.)

**WHEREAS**, in the wake of spread of Coronavirus (COVID-19), the Central Government under the direction of National Disaster Management Authority, had ordered a Total Lockdown of 21 days throughout the Country from 25<sup>th</sup> March, 2020, in order to contain the spread of the said coronavirus. Under further directions of NDMA, the Central Government further extended the said Lockdown till 03<sup>rd</sup> May, 2020;

**AND WHEREAS**, the Central Government has further extended the said Lockdown till 31<sup>st</sup> May, 2020, vide Order No. 40-3/2020-DM-I(A) dtd. 17<sup>th</sup> May, 2020, issued by the Union Home Secretary, Ministry of Home Affair, Govt. of India;

**AND WHEREAS**, in conformity with the Order dtd. 17<sup>th</sup> May, 2020 mentioned above, the U.T. Administration of Dadra & Nagar Haveli and Daman & Diu has also extended the Lockdown in the territory vide Order No. DMHS/COVID-19/2020/4167 dtd. 17<sup>th</sup> May, 2020 issued by the Secretary (Health & Family Welfare), D&NH and D&D;

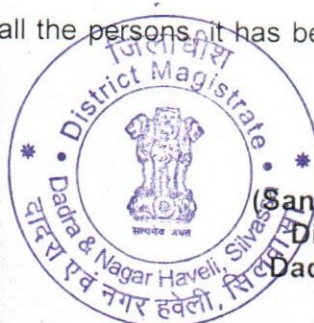
**THEREFORE**, in conformity with the Order dtd. 17<sup>th</sup> May, 2020 issued by the MHA read with Order dtd. 17<sup>th</sup> May, 2020 issued by the U.T. Administration and in exercise of the powers conferred under section 144 of Code of Criminal Procedure, 1973, I, Sandeep Kumar Singh, District Magistrate, Dadra & Nagar Haveli, hereby order as follows:

1. Assembly of 05 or more persons shall be prohibited.
2. No movement by any person shall between 04:00 p.m. to 08:00 a.m. except for medical emergencies and essential services emergencies.
3. All the directions issued by the Central Government of India vide Order No. 40-3/2020-DM-I(A) dtd. 1<sup>st</sup> May, 2020 and Order No. DMHS/COVID-19/2020/3672 dtd. 3<sup>rd</sup> May, 2020, issued by the Secretary (Health & Family Welfare), Dadra & Nagar Haveli and Daman & Diu, shall be strictly complied with by all the persons in the District.
4. All passes and permissions issued by the District Administration shall remain valid till **31<sup>st</sup> May, 2020.**

This Order is issued in supersession of all the previous Orders issued under section 144 of Code of Criminal Procedure, 1973, related to coronavirus (COVID-19)

This Order shall come into force immediately from the date of issue and shall remain in force till 31<sup>st</sup> May, 2020.

As this order cannot be served to all the persons, it has been put in the public domain for information of the public at large.
