In exercise of the powers conferred by section 35 of the Inter-State Migrant Workmen (Regulation of Employment and Conditions of Service) Act, 1979 (Central Act 30 of 1979), the Government of Kerala, hereby make the following rules further to amend the Kerala Inter-State Migrant Workmen (Regulation of Employment and Conditions of Service) Rules, 1983, the same



having been previously published under notification No.LBRD-E2/30/2021-LBRD dated 26th July, 2024 in the Kerala Gazette Extraordinary No.2443 dated 29th July, 2024 as required by sub-section (1) of the said section, namely:-

RULES

1. Short title and commencement .- (1) These rules may be called the Kerala Inter-State Migrant

Workmen (Regulation of Employment and Conditions of Service) Amendment Rules, 2025.

(2) They shall come into force at once.

2. *Amendment of the Rules* .- In the Kerala Inter-State Migrant Workmen (Regulation of Employment and Conditions of Service) Rules, 1983,-

(1) in rule 12,-

(a) in sub-rule (1), for the existing "TABLE", the following "TABLE" shall be substituted, namely:-

(b) in sub-rule (2), for the existing "TABLE", the following "TABLE" shall be substituted, namely:-

2) in rule 16, for the letters, symbol, figure, words and brackets "Rs. 50 (Rupees fifty only)", the letters, symbol, figure, words and brackets "Rs. 55 (Rupees fifty five only)" shall be substituted.

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

As per rule 12 of the Kerala Inter-State Migrant Workmen (Regulation of Employment and Conditions of Service) Rules, 1983, the fees to be paid for the grant of Certificate of Registration of an establishment under section 4 and for the grant of licence under section 7 shall be as specified. The



Government have amended the above said rule and revised the rate of fees payable for the grant of Certificate of Registration and licence vide notification issued under G.O.(P).No.89/2013/LBR. dated 16th July, 2013 and published as S.R.O.No.575/2013 in the Kerala Gazette Extra Ordinary No.2160 dated 23rd July, 2013. Now, the Government have decided to further amend the sub-rule (1) and (2) of rule 12 and rule 16 and to revise the rate of fees mentioned in the said rule shown as above.

The notification is intended to achieve the above object.
