ORDER

WHEREAS, in the wake of spread of Coronavirus (COVID-19), the Ministry of Home Affairs vide it's Order No. 40-3/2020-DM-I(A) dtd. 24th March, 2020, had ordered a Total Lockdown of 21 days throughout the Country from 25th March, 2020, in order to contain the spread of the said coronavirus;

AND WHEREAS, vide its subsequent orders of even number, the said Lockdown was extended from time to time till 31st May, 2020;

AND WHEREAS, the Ministry of Home Affairs vide its Order No. 40-3/2020-DM-I(A) dtd. 30th May, 2020, has extended the Lockdown only for the areas which are identified as Containment Zone in the Country upto 30th June, 2020 and has directed to re-open prohibited activities in a phased manner in areas outside Containment Zones;

NOW THEREFORE, in view of above and in exercise of the powers conferred under Section 144 of Code of Criminal Procedure, 1973, I, Sandeep Kumar Singh, District Magistrate, Dadra & Nagar Haveli, hereby order as under:

- 1. Assembly of 05 or more persons shall be prohibited.
- 2. Movement of individuals shall remain strictly prohibited between 07:00 p.m. to 07:00 a.m. except for medical emergencies and essential services emergencies.
- 3. All the shops in Dadra & Nagar Haveli shall be allowed to remain open from 07:00 a.m. to 07:00 p.m.
- 4. All the directions issued by the Central Government of India vide Order No. 40-3/2020-DM-I(A) dtd. 30th May, 2020 and Order No. DMHS/COVID-19/2020/4618 dtd. 31st May, 2020 issued by the Secretary (Health & Family Welfare), D&NH and D&D, shall be strictly complied with by all the persons.

This Order shall come into force immediately from the date of issue and shall remain in force till 30th June, 2020.

information of the public at large.
