Order

In continuation of this office order vide Endst. No. 5205-5305/MA/CO, Dated 8-5-2020 and Additional Chief Secretary to Govt. of Haryana, Urban Local Bodies Department, Chandigarh Memo no. ADULB/Admn./2020/28396 dated 18-5-2020, ADULB /Admn./2020/29054 dated 23-5-2020 slight modification/ relaxation is hereby done.

Hence in pursuance of the aforementioned directions and in exercise of powers conferred under section 30(2)(iv) of the Disaster Management Act, 2005, and in consultation with different market commodities's associations it is hereby ordered that the aforementioned New Guidelines (As per Ministry of Home Affairs (MHA) Order No.40-3/2020- DM-I(A) dated 17th May, 2020) and Chief Secretary-cum-Chairperson, Haryana State Executive Committee, Govt. of Haryana, Haryana State Disaster Management Authority vide order No. DMC-SPO-2020/5688 Dated 17-5-2020 as well as the National Directives as must be enforced by all concerned/stakeholders in the manner prescribed below: -

- All eateries, restaurants etc. will not be allowed to provide sit-dine services to general public. They are allowed only for home deliveries and take away purposes from 9:00 AM to 6:00 PM.
- 2. Fruits and Vegetables markets in the market committee areas will perform their work of wholesale from 7:00 AM to 10:00 AM, no retail will be allowed.
- 3. All private establishments's offices will be open from 9:00AM to 5:00 PM
- 4. Shops will be allowed for runnig in the MC area as per the scheduled prescribed below:-

- The shop owner shall ensure that no customer is allowed to enter the shop without thermal scanning, sanitization and mask. It shall also be ensured that not more than 5 persons including shopkeeper, helpers & customers are present at time in any shop.
- vi. The customers/visitors should wear masks and be asked to stand in queue at a disance of minimum 6 feet. Proper marking of circles at the required distance should be done on regular basis so that customers/visitors shall wait for their turn.
- vii. Temporary barriers with thermal scanning system should be provided at the entry and exit points of these market places so as to maintain the flow of customers/visitors for ensuring social distancing
- viii. The customers visiting these market places should not park their vehicles (both two-wheelers and four-wheelers) in front of any shop/rehris but park these vehicles at designated parking places and walk on foot to the market place. Further while coming out of their vehicles they shall maintain social distancing. It shall also be ensured that the parking areas are managed properly.
- ix. Citizens should be motivated to visit in minimum numbers (only one member of the family at a time) to these market areas to avoid over-crowding.
- x. Municipal staff shall ensure proper cleanliness and sanitization of such market vil. places/areas at regular intervals during day as well as night Challaning should be strictly enforced against spitting in open/market areas.
- xi. Shopkeepers/Street Vendors shall display a Public Notice regarding downloading of "Aarogya Setu Mobile App" for public/customer awareness and motivate them to install the same and regularly update their health status on this app. The shopkeepers shall ensure that all the employees must install Aarogya Setu Mobile App and use the sane regularly.
- xii. Display the above advisory should be pasted by the owner of shopkeepers/vendors.
- 5. Food restaurants and food aggregators like Zomato, Swiegy etc. are permitted to operate kitchens for home delivery of food items. They shall ensure that all standards of hygiene like wearing of masks, gloves, caps etc are being followed while cooking food in such kitchens. It shall be ensured that kitchen staff or delivery boys are not having any illness or symptoms of cold and cough etc. The thermal scanning of staff on daily basis and regular medical checkup of all such staff be ensured by the owner. Delivery boys shall wear gloves and masks during home delivery. No signature/thumb impression of the customer shall be taken by them while delivering the items. Preferably online electronic mode of payment shall be ensured to avoid contact and to maintain social distancing.

- Above mentioned order will also be implemented as such in residential and commercial sectors of HSVP except malls.
- 7. Executive Officers/Secretary, Municipal Council/Committees and SHO (Traffic) or SHO concerned shall identify suitable sites/locations for parking of vehicles in a staggered manner.
- 8. Sub Divisional Magistrate/Incident Commanders/Duty Magistrate, will ensure the compliance and implementation of these orders. They can add more restrictions in their respective narrow lane market areas, without changing the timings and schedules of days given in the order. Further the SDMs may change orders based on congestion of the market where its 50 percent of all shops.
- A Team headed by City Magistrate, Kurukshetra shall also supervise and carry out surprise inspection in the Kurukshetra city area for the said purpose.
- 10. D.E.T.C. (ST), Kurukshetra, Deputy Director Agriculture, Kurukshetra, Executive Officers/ Secretary, Municipal Council/Committees; Secretary Market Committees; Labour Officer; Drugs Control Officer, Food Safety Officer; SHO Traffic Police shall also mobilize their resources to carry out constant inspections in the markets to avoid over-crowding and ensure social distancing norms. These orders will be implemented till further Orders.
- 11. This SOP shall come into effect from today i.e, 25.05.2020. All Municipalities shall ensure to arrange for wide publicity by MUNADI on its own vehicles being used for door-to door garbage collection vehicles having Public Address System (PAS) facility or by hiring vehicles for this purpose today itself on priority basis. Wide publicity may also be carried out through press release and social media.
- 12. Further, Market and Trade Associations be also contacted and requested to motivate the shopkeepers/street vendors in their respective areas for adhering to these guidelines from 25.05 2020. The report regarding MUNADI with photos be forwarded to this office on priority.

Strict compliance of the above directions be ensured by all concerned.

Superintendent of Police to direct all SHO's for strict implementation of the above modification/relaxations. The public in general are advised to implement of the modification/relaxation.

Failure to obey these orders shall be penalized under section 188 of I.P.C. with punishment of severe fine and imprisonment.

In view of requirement of the situation which has become emergent, this order, is being passed ex-parte. It shall be published for the information of public through the press and publicity van of public relations department and by affixing copy at notice board of District Courts, Zila Parishad, Sub Divisions, Tehsils, Municipal Council, Municipal Committees, Panchayat Samities, Police Stations and Public Places.
