

## ORDER

Whereas the MHA, Govt. of India, vide its order No. 40-3/2020-DM-1(A) dated 17.05.2020 has extended the lockdown for a further period upto 31<sup>st</sup> May, 2020 and in pursuance with the directions/ SOP issued by Additional Chief Secretary to Govt. Haryana, Urban Local Bodies Department vide memo No. ADULB/Admn./2020/28396 dated 18.05.2020.

In view of the apprehension of the community transmission of the nCOVID-19 epidemic, it is expedient that precautionary measures should be taken to prevent & contain the spread of nCOVID-19 for human health and safety of general public in District Jhajjar.

Now, I, Jitender Kumar, IAS, District Magistrate-cum-Chairman, District Disaster Management Authority, Jhajjar in exercising the powers conferred under "The Disaster Management Act, 2005" and "Epidemic Disease Act, 1897", following Restrictions/ timing of operation of activities in district Jhajjar excluding containment zone are hereby imposed/ fixed as under:-

1	All eateries, restaurants etc. will not be allowed to provide sit-dine services to general public. However, they are allowed only for home deliveries and take away purposes.	Daily 9:00 AM to 6:00 PM.
2	Milk and Dairy Products, fruit, vegetable, Grocery Shops.	Daily 7.00 AM to 10: 00 AM and 4.00 PM to 7.00 PM
3	Sweets shops, Tea-Stalls, Green/Dry Fodder, Confectionary, Pesticides/ Seeds/ Fertilizers, Agriculture/ Horticulture Implements, Animal feed, Book stalls/ Stationery, Photostat/Forms, Vita Booths, Dry-Cleaners, Agriculture shops, Auto parts, Tyre/Tubes, Hardware store, Industrial goods.	Daily 9:00 AM to 6:00 PM.
4	General store, Shoe-Chappal, Cloth, Readymade Garments, Handloom, Furniture (Wooden/plastic) , Tent House, Barber	Monday, Wednesday and Friday 9.00 AM to 6.00 PM
5	Iron store, sanitary stores, Shuttering material, Building construction materials, Stone/tiles, Electric and Electronic goods, Mobiles/IT/Computer sale Service spares; Optical, watches, Crockery, Utensils, Jewellery and all other type of shops not mentioned at Sr. 2, 3 & 4 above except liquor shops .	Tuesday, Thursday and Saturday 9.00 AM to 6.00 PM
6	Petrol pumps	7:00 AM to 7:00 PM daily

- All standalone (single shops), neighbourhood (colony)shops and shops in residential areas shall be opened daily from 9.00AM to 6.00 PM

Following measures shall be strictly adopted:-

- i. Wearing of masks/face cover is compulsory both for the shopkeepers and the customers.
- ii. Social-distancing norms shall be followed for which marking at 6 ft. gap be done in front of the every shop
- iii. Shopkeepers should wear gloves and masks to avoid hand contact. They shall ensure frequent sanitization of all points which come into human contact e.g. door handles etc.
- iv. Hand-Sanitization must be available at the shop
- v. Shops counters/desks/chairs should be sanitized twice a day
- vi. There shall be no parking of vehicles in front of the shops.
- vii. No shop-keeper will put any products/items/objects outside his shop.
- viii. All shops, except medical halls, fruit/ vegetable and milk/dairy shops, shall remain closed on Sunday.
- ix. There shall be not more than five person in the shop (including shopkeeper and helpers) at a time
- x. It shall be responsibility of the shopkeeper concerned to ensure compliance. If contravenes, his permission shall be withdrawn.
- xi. All shopkeepers shall download Aarogya Setu App in their mobiles and all in the mobiles of all customers compulsorily.
- xii. Spitting at public place shall be punishable with fine which may be Rs.200/- for each offense.
  - Above mentioned order will be implemented on commercial shops except HSVP markets big malls as well as shopping complexes
  - Executive Officers/Secretary, Municipal Council/Committees and SHO (Traffic) or SHO concerned shall identify suitable sites/locations for parking of vehicles in a staggered manner.
  - Sub Divisional Magistrate/Incident Commanders, Jhajjar, Bahadurgarh, Beri, Badli shall constitute Inspection Teams in order to regulate the crowd in markets; maintenance of social distancing in the markets and over-see that no shop runs out of fixed time limit and also to take action against the violators.
  - A Team headed by City Magistrate, Jhajjar shall also supervise and carry out surprise inspection in the MC limit of Jhajjar town for the said purpose.
  - D.E.T.C. (GST), Jhajjar, Deputy Director Agriculture, Jhajjar, Executive Officers/Secretary, Municipal Council/Committees; Secretary Market Committees; Labour Officer; Drugs Control Officer, Food Safety Officer; SHO Traffic Police shall also mobilize their resources to carry out constant inspections in the markets to avoid over-crowding and ensure social distancing norms.

DIG-cum-Superintendent of Police, Jhajjar to direct all SHO's for strict implementation of the restrictions. However, the nCOVID-19 is a disaster for the country. Hence, the public in general are advised to inform the concerned SHO if any seen violating the orders.
