CONTRACT LABOUR (REGULATION AND ABOLITION) ACT, 1970.

No.: GR/2022/135/LBL/192020/510460/M3:- The following draft of rules which is proposed to be issued under section 35 of the Contract Labour (Regulation and Abolition) Act, 1970 (37 of 1970) is published as required under sub-section (1) of section 35 of the said Act for information of all persons likely to be affected thereby and notice is hereby given that the said draft rules will be taken into consideration by the Government of Gujarat on or after the expiry of thirty days from the date of publication of this notification in the *Official Gazette*.

DRAFT NOTIFICATION

CONTRACT LABOUR (REGULATION AND ABOLITION) ACT, 1970.

No: GR/2022/135/LBL/192020/510460/M3:- In exercise of the powers conferred by section 35 of the Contract Labour (Regulation and Abolition) Act, 1970 (37 of 1970), the Government of Gujarat hereby makes the following rules further to amend the Contract Labour (Regulation and Abolition) (Gujarat) Rules, 1972, namely: -

- 1. (1) These rules may be called the Contract Labour (Regulation and Abolition) (Gujarat) (Amendment) Rules, 2022.
 - (2) They shall come into force on the date of their publication in the *Official Gazette*.

IV-A Ex.-125

- 2. In the Contract Labour (Regulation and Abolition) (Gujarat) Rules, 1972, -
 - I. In rule 18, after sub-rule 1, the following rule shall be inserted namely:-
 - "(A) The Registering officer shall grant the registration within 45 days after the application if satisfied about the eligibility of the applicant. In case of failure to issue registration within stipulated time shall be deemed approval"
 - II. In rule 23, after sub-rule 1, the following rule shall be inserted namely:-
 - "(A) The Licensing officer shall grant the license within 45 days after receiving the application if satisfied about the eligibility of the applicant. In case of failure to issue license within stipulated time shall be deemed approval"
