Dear Sir/Madam,

It is to bring to your notice that the Ministry of Labour and Employment has decided to link ESIC Insurance Number of insured persons with their EPFO's Universal Account Number (UAN), a 12-digit identification number allotted by EPFO.

EPFO members with authorized Aadhaar & Bank details seeded against their UAN can submit their PF withdrawal/Settlement/Transfer requests. A provision has been made in the ESI portal where the employer can enter the UAN of IPs through the module. Once it is entered in the system, the same can be verified with EPFO.

Hence it is requested to enter UAN of your employees in the Insurance module of ESI Corporation, for ease of access to various provisions of the Act.
