No. FW/Election, 2022/2704 -Whereas the Re-poll for the post of Panch, ward no-4 & 6, Gram Panchayat, Lisana, Block Rewari, District Rewari for which Re-poll shall be held on the 14.11.2022(Monday) as per letter of the State Election Commission, Haryana issued vide No. SEC/4E-II/2022/5677-5678 dated 12.11.2022.

And whereas, it has been considered necessary to provide opportunity to the public to exercise their franchise.

Now, therefore, in exercise of the powers conferred by sub-section (2) of Section 65 of the Factories Act, 1948 (Central Act 63 of 1948) and all other powers enabling him in this behalf, the Governor of Haryana is pleased to exempt all the adult workers working in the factories situated in the State of Haryana who are the voters in re-poll for election of Panch, ward no-4 & 6, Gram Panchayat, Lisana, Block Rewari, District Rewari and are entitled to vote at an election to the Panchayati Raj Institutions on the day of re-polling from the operations of provision of sub-section (1) of section 52 of the said Act for the weeks commencing from 13.11.2022 and ending 19.11.2022, subject to the condition that no adult worker who is enrolled as the voters in re-poll for election of Panch, ward no-4 & 6, Gram Panchayat, Lisana, Block Rewari, District Rewari be required or allowed to work on 14.11.2022(Monday) in the factories of the State of Haryana.
