No. FW/Election,2022/1692 -Whereas the General Election of Panchayati Raj Institutions in 09 Districts namely Bhiwani, Jhajjar, Jind, Kaithal, Mahendergarh, Nuh, Panchkula, Panipat and Yamunanagar for which poll shall be held on the 30.10.2022(Sunday) and 02.11.2022 (Wednesday) as per letter of the State Election Commission, Haryana issued vide No. SEC/4E-II/2022/3173-3174 dated 07.10.2022 read with Letter No. SEC/4E-II/2022/3274 dated 08.10.2022

And whereas, it has been considered necessary to provide opportunity to the public to exercise their franchise.

Now, therefore, in exercise of the powers conferred by sub-section (2) of Section 65 of the Factories Act, 1948 (Central Act 63 of 1948) and all other powers enabling him in this behalf, the Governor of Haryana is pleased to exempt all the adult workers working in the factories situated in the State of Haryana who are the voters in districts as mentioned below in the table and are entitled to vote at an election to the Panchayati Raj Institutions on the day of polling from the operations of provision of sub-section (1) of section 52 of the said Act for the weeks as mentioned in the below table subject to the condition that no adult worker who is enrolled as the voters shall be required or allowed to work on the polling day.


