सं. 15(52)/लैब/2021/4506.—दिल्ली दुकान और प्रतिष्ठान अधिनियम, 1954 (दिल्ली अधिनियम 1954 का 7) की धारा 47 की उप-धारा (1) में प्रदत्त षक्तियों का प्रयोग करते हुए, दिल्ली दुकान और प्रतिष्ठान अधिनियम, 1954 में संशोधन करने के लिये प्रारूप नियम दिल्ली राजपत्र असाधारण भाग-4 में अधिसूचना संख्या 15(52)/लैब/2021/3618-3626 दिनांक 24 सितम्बर 2021 द्वारा अधिसूचित किया गया, जिससे इससे प्रभावित होने की सम्भावना वाले व्यक्तियों की जानकारी के लिये और यह सूचना दी गयी कि इस अधिसूचना के प्रकाशन की तारीख से 15 दिनों की अवधि के समाप्ति के बाद, इसके संबंध में निर्धारित अवधि तक प्राप्त आपतियों और सुझावों के साथ इसे विचार किया जायेगा।

उक्त 15 दिनों की अवधि में कोई आपति या सुझाव प्राप्त नहीं हुआ और उक्त प्रारूप नियमों को उपराज्यपाल, दिल्ली, की स्वीकृति के बाद निम्नानुसार समापक किया जाता है।

- (1). इन नियमों को दिल्ली दुकान और प्रतिष्ठान (संशोधन) नियम, 2021 कहा जा सकता है।
- (2). वे दिल्ली राजपत्र में उनके प्रकाशन की तारीख से लागू होंगे।

### NOTIFICATION

Delhi, the 15th November, 2021

**No. 15(52)/Lab/2021/4506.**—In exercise of the powers conferred by sub-section (1) of Section 47 of the Delhi Shops and Establishments Act, 1954 (Delhi Act, 7 of 1954), the draft rules further to amend the Delhi Shops and Establishments Rules, 1954, was notified in the Delhi Gazette, Extra Ordinary Part IV vide notification no. 15(52)/Lab/2021/3618-3626 dated 24/09/2021, for the information of the persons likely to be affected thereby and notice was given that the said draft would be taken up for consideration, after the expiry of a period of 15 days from the date of publication of the notification in the Delhi Gazette together with the objections and suggestions received in respect thereto, by the stipulated period.

No Objection or suggestion was received in the aforesaid period of 15 days and the said draft rules after taking approval of Lieutenant Governor, Delhi is finally published as under :-

#### 1. Short title and commencement:-

- (1). These rules may be called the Delhi Shops and Establishments (Amendment) Rules, 2021.
- (2). They shall come into force on the date of their publication in the Delhi Gazette

#### 2. Substitution of New Rule for Rule 3:-

In the Delhi Shops and Establishments Rules, 1954 (hereinafter referred to as “the principal Rules”) for rule 3, the following rule shall be substituted, namely:- “3. **Form of submitting statement and other particulars under sub-section (1) of section 5-** The occupier of the establishment, within 90 days of the commencement of work of his

establishment shall apply for the registration under the Act, online on the Shop and Establishment Portal of Labour Department.

**3. Amendment of Rule 4-**

In the Principal Rules, for rule 4, the following rule shall be substituted, namely:- **4 Manner of registering establishments and form of registration certificate** – On submission of application online on the Shop & Establishment portal of Labour Department, Government of NCT of Delhi, the registration certificate shall be generated online in Form C.

**4. Amendment of Rule 6:-**

In the Principal Rules, for rule 6, the following rule shall be substituted, namely:-**6. Form and manner of notifying change-** The occupier shall notify any change in respect of any information under sub-section (1) of section 5 of the Act within 30 days after such change has taken place, online, on the Shop & Establishment Portal of Labour Department, Government of National Capital Territory of Delhi.

**5. AMENDMENT OF SCHEDULE - I**

In the Principal Rules, the Schedule I is deleted.

**6. AMENDMENT OF SCHEDULE - II:-**

In the Principal Rules, the schedule II is deleted.
